KEY MESSAGES

Climate risk is financial risk – and time is running out to address it. In the words of UN Secretary General António Guterres:

"the battle for 1.5 degrees will be won or lost in the 2020s".

Investors are taking climate action, but the evolution of a more effective enabling policy environment is required

Hundreds of investors have committed to address climate risk and support net zero emissions by 2050 or sooner, in line with their fiduciary duties. However, we must see these commitments translate into real world change more quickly. This, now more than ever, requires decisive action from policymakers to enable investor action.

PRI's Priorities for New York Climate Week:

Advocate for an enabling policy environment to facilitate responsible investment practice

Support accelerated investor action, including through collaborative initiatives on climate, nature and adaptation

Enhance the impact of climate action within the US responsible investment ecosystem



PRI'S POLICY ASKS

Policymakers must act with urgency to mitigate systemic risks, seize the opportunities of an economic transition to net zero, and provide certainty and stability for investors. PRI has prioritised the following policy asks, in keeping with the feedback and needs of our signatories.

FINANCIAL

Provide clear guidance on Paris-aligned entity-level transition planning for investors and corporates

Adopt ISSB disclosure standards – IFRS S1 and IFRS S2 – on an economy-wide basis by the end of 2025.

Facilitate and safeguard collaborative investor action on climate issues.

Clarify when investors' legal duties enable or require them to consider pursuing sustainability impact goals

REAL ECONOMY

Develop a whole of government approach to
the net zero transition, that
addresses key socio-economic
implications, and place that at
the heart of policymaking

Ensure the next generation of NDCs are ambitious, credible platforms for investment aligned with 1.5c pathways and supported by relevant legislation, transition plans and policy reforms

Implement robust carbon pricing mechanisms to incentivise cross-sectoral low-carbon solutions.

Commit and accelerate the full and equitable phaseout of fossil fuel subsidies by G20 members

Implement the Global Pledge on Renewables and Energy Efficiency

Connect climate mitigation, adaptation and nature in reforms, including ensuring NDCs are linked with National Biodiversity Action Plans and National Adaptation Plans

MULTI-LATERAL

Align the multilateral financial architecture with ambitious sustainability goals to direct capital flows to emerging and developing economies

Ensure the New Collective and Quantified Climate Finance Goal at COP29 gives clear signals on the role of private finance and meets the needs of EMDEs
